##### **1. The scope of these terms and conditions of use**

By using/visiting the websites operated by the Foundation you accept these Terms and Conditions of Use without any limitation and/or modification. If you do not want to accept our terms of use in full, please do not use these websites.

##### **2. Description of the mideas programme**

The purpose of the mideas programme is to find innovative young people – mainly those related to Hungary in some way – who are thinking of starting businesses that may be expanded globally. The aim of mideas is to give assistance to achieve business success, as early as in stage zero. With this in mind, Foundation, the operator of the mideas programme, created the Websites, through which it provides opportunity for Users to register for participation in the programme.

In order to participate in the mideas programme, you have to register on the website of the programme, and you need to provide the requested data.

##### **3. Rights relating to the content of the websites of Foundation**

The entire content of the website of the Foundation and the website of the mideas programme - all text and all graphics (the "Content") - is the (intellectual) property of Foundation and we reserve all rights to such content unless any comment to the contrary is indicated.

It is prohibited to use the Content in any way unless such use is in accordance with these terms and conditions or is permitted based on the written authorisation of the person entitled to give such authorisation (for more information on this, see section 4).

The Foundation would like to call the attention to the fact that it will use any and all available legal means and opportunities to protect its intellectual property from unauthorised use.

#### **4. Using the website of the Foundation**

The Foundation permits the use of its websites under the following terms and conditions:

- Only the designated Content may be downloaded and only for private purposes provided that they fully retain all comments concerning copyright and other comments concerning owners or rightsholders;
